## **European Studies**

Learning outcomes:

- 1. Drawing on a wide range of courses in the humanities and the social sciences, students will identify crucial events, actors, and trends with significant impact in Europe.
- 2. Students will demonstrate an understanding of the range of diverse historical, political, economic, and cultural experiences and values that shape European identity.
- 3. Students will gain an ability to critically evaluate various consequences of Europe's interaction with the rest of the world as well as sources of tensions that are causing political upheavals in Europe.

#### **Global Studies Certificate**

Learning outcomes:

- 1. Drawing on a wide range of courses in the humanities and the social sciences, students will demonstrate an understanding of world cultures, politics, and economies within the context of globalization, as well as develop the skills and attitudes to function as global citizens.
- 2. Students will learn about the significant developments in the world today, including the threats of global warming, poverty, and the escalation of armed conflict.
- 3. Students will be able to draw on multiple perspectives to gain a critical insight into the role states and regions play within the global system, including various interdependencies amongst nations.

### **Latin American Studies**
