HOW TO APPLY FOR CO-ADMISSION

Complete the application for co-admission and submit it to the Portland Community College Office of Admissions with the \$50 non-refundable fee payable to Portland State University and \$25 to Portland Community College. If you are a current PSU or PCC student, you need not pay the fee at that school. If you are enrolling for the first time to either PCC or PSU, you must also submit official transcripts. To be official, transcripts must be submitted in the original, sealed envelope. Transcripts in languages other than English must be accompanied by certified English translations. If you are currently enrolled at PCC, PCC will forward to PSU any transcripts that it has on file. All other transcripts must be sent directly to PSU.

MINIMUM ADMISSION REQUIREMENTS

FRESHMAN ADMISSION (fewer than 24 transferable college quarter credits)

1. Graduate from a standard or accredited high school¹ with a minimum 3.0 grade point average (GPA). Students who do not have this cumulative GPA requirement may meet this requirement with a Scholastic Aptitude Test (SAT) combined score of 1000 (critical reading and math) or higher or an American College Test (ACT) composite score of 21 or higher.
2. Take the SAT and/or ACT and have scores sent directly to Portland State University. No minimum score is required unless student does not meet minimum GPA (see above).
3. Complete 14 units of college preparatory work (courses must be completed with a grade of C- or better) or submit Proficiency-based Admission Standards (PASS) scores of M, H, or E:
 - 4 years/units of English
 - 3 years/units of math to include 1 year of Algebra 2 or higher math
 - 3 years/units of social studies
 - 2 years/units of science
 - 2 years/units of, or demonstrated proficiency in, a second language. This requirement applies to all students graduating from high school in 1997 or any year after.

¹Graduates from non-accredited or non-standard high schools must also take two SAT subject tests of the student's choice, earning a minimum of 470 on each subject test OR complete a GED. Students who earn a GED must earn a minimum overall average score of 460 and a minimum score of 410 on each subject test as well as meet the two-year language proficiency requirement.

TRANSFER ADMISSION (24 or more transferable quarter credits)

1. Meet minimum GPA requirement: 2.25, or 2.0 if presenting a transferable Associate's Degree or an Oregon Transfer Module (OTM).
2. Meet the two-year language proficiency requirement described above if you graduated from high school in 1997 or after.

INTERNATIONAL STUDENT ADMISSION

1. Meet minimum cumulative GPA requirement of 3.0 for freshmen and/or 2.50 for transfer students.
2. Meet minimum Test of English as a Foreign Language (TOEFL) score of 525.

IMPORTANT: PCC does not approve concurrent enrollment for international students on a PCC I-20. If you want PCC/PSU co-admissions and take part-time courses at both institutions, you will need to be on a PSU I-20. International students must be on either a PCC or PSU I-20. As long as you are enrolled at 12 PCC during a particular quarter, you may take additional credits at PSU.

SOCIAL SECURITY NUMBER DISCLOSURE STATEMENT

PCC: Providing your Social Security Number (SSN) is voluntary. If you provide it, the college will use your Social Security Number for keeping records, doing research and reporting. The college will not use your number to make any decision directly affecting you or any other person. Your Social Security Number will not be given to the general public. If you choose not to provide your Social Security Number, you will not be denied any rights as a student. Please read the statement with the registration information in your class schedule which describes how your number will be used. Providing your Social Security Number means that you consent to the use of the number in the manner described.

PSU: You are requested to provide voluntarily your SSN to assist OUS (Oregon University System) and organizations conducting studies for or on behalf of OUS in developing, validating, or administering predictive tests; administering student aid programs; improving instruction; internal identification of students; collection of student debts; or comparing student educational experiences with subsequent workforce experiences. OUS will disclose your SSN only if the studies are conducted in a manner that does not permit personal identification of you by individuals other than representatives of OUS (and organizations conducting the study for OUS) and only if the information is destroyed when no longer needed for the purposes for which the study was conducted. By providing your SSN, you are consenting to the uses identified above. This request is made pursuant to ORS 351.070 and 351.085. Provision of your SSN and consent to its use are not required and if you choose not to do so you will not be denied any right, benefit, or privilege provided by law. PSU TUITION CLASSIFICATION INFORMATION

Residency at PSU is determined in the evaluation of location of domicile, financial dependence or independence, primary purpose for living in Oregon, type and source of financial resources as well as other indicators. The primary determinant for residency is intent. That is, if you have moved to Oregon primarily for the purpose of obtaining an education, residency status is not granted regardless of elapsed time since moving to Oregon. Note that students who take 8 credits or fewer per term at PSU will not be assessed non-resident tuition rates.

You may be considered a resident if:

- You moved to Oregon for reasons other than to attend school
- You have lived in Oregon for at least 12 months before registering as a full-time student
- You are financially dependent upon an Oregon resident
- You have been claimed as a dependent for tax purposes by an Oregon resident who has been living in Oregon for at least 12 months
- You are financially independent and meet a and b above
- You are a member of the armed services assigned to duty in Oregon.

You may be considered a non-resident if:

- You enrolled in a college or university more than part-time (9 or more credits) within 12 months of moving to Oregon
- You have been claimed as a dependent on State and/or Federal tax returns by someone living in another state
- Your primary source of financial support comes from someone living outside of Oregon
- You are an alien possessing one of the following non-immigrant or temporary visas: B, C, D, F, J, M.
