5	THIS LETTER OF AGREEMENT SETS FORTH THE FOLLOWING AGREEMENT BETWEEN GRADUATE
6	EMPLOYEE UNION, LOCAL 6666 AND PORTLAND STATE UNIVERSITY IN ACCORDANCE WITH GOOD
7	FAITH AND FAIR DEALING
8	1. PSU and GEU are parties to a collective bargaining agreement (CBA) for the period March 28, 2018 to June 30,
9	2021
10	2. Article 19. Salary, Section 4 Cost of Living Adjustment of the CBA references the Portland-Hillsboro-Vancouver
11	Consumer Price Index (CPI) for all urban consumers.
12	3. The parties expected that US Department of Labor Bureau of Labor Statistics (BLS) Consumer Price Index- (the
13	newly created NH49H for Portland-Vancouver-Hillsboro, OR-WA MSA) would be available in August 2018.
14	4. The BLS did not publish the NH49H for Portland-Vancouver-Hillsboro, OR-WA data set as expected in August
15	2018.
16	5. A new CPI-U index is required to apply to COLAs in Article 19, Section 19.5, in the academic year 2019-20120.
17	6. GEU and the University agree to use the Consumer Price Index, West Region for the academic year 2019-2020
18	
1	COLAs in CBA Article 19, Section 19.5 <sup>1</sup> .
19	7. For the purposes of Article 19, Section 19.5- the following changes to existing language shall apply:
20	a. "CPI" means the Western Region Consumer Price Index for All Urban Consumers (CPI-U) for the previous
21	12-month period as published in or near the month of November each year by the U.S. Department of
22	Labor's Bureau of Labor Statistics.
23	8. COLA will be applied in the amount of 3.3% in accordance with the CBA for the academic year 2019-2020
24	COLAs in CBA Article 12, Section 4.
25	9. The parties agree that this Letter of Agreement is applicable for each remaining year of the contract except in the
26	event the CPI chart changes and bargaining is required.
27	
28	This Agreement is effective upon signature of all parties and shall be attached to the current CBA.
