

## **Key Outcome Evaluation Findings**

**Family Connections Oregon (FCO)** was a demonstration project funded by the Children's Bureau with both service delivery and systems change components. Service delivery consisted of a co-located FCO Coordinator that provided a package of services (intensive family finding and engagement, family group conferencing [FGC], and follow-up) within the first 60 days of a child's out-of-home placement. Systems change sought to install leadership, workforce, and infrastructure supports for sustainable family meeting practice in Oregon.

## **Service Delivery Outcomes**

Trends (not statistically significant) in child welfare outcomes compared to control children	• FCO children spent fewer days in paid foster care than control

**Evaluation Limitations:** Small sample sizes made it difficult to find statistically significant results when analyzing quantitative data, and to generalize findings. Reasons for small sample sizes for the FCO evaluation were:

- Fewer children met eligibility criteria than expected (1 site)
- Coordinators able to handle fewer cases than expected
- Difficulty getting permission to contact families randomly assigned to control group
- Short program duration (2 years) and limited follow-up timeframe (6 months)

Continuum of Five Meetings Model presented to DHS leadership; basis for policy option package for 2016 legislative session

Significant influence on new Title IV-E Waiver Demonstration project planning (Leveraging Intensive Family Engagement, or LIFE)

Ongoing state-level parent advisory board with sustainable funding

Elements of FCO Model included in new meeting facilitator training provided by Child Welfare Partnership at PSU Ongoing family meeting practice course offered at the School of Social Work at PSU
