# PA 567: Energy Resources Policy & Administration

(Also known as "Northwest Energy Policy & the Columbia River")

### **Course Description**

This course explores the history, politics, and institutions related to current energy policy and administration, with particular attention to the distinctive nature of energy policy issues in the Pacific Northwest and the Columbia River Basin. It provides social science theories and analytical tools to help graduate students and energy professionals navigate the complexities of the energy sector.

This course was created in 1984 at the request of the Administrator of the Bonneville Power Administration (BPA) and has been offered annually ever since. For many years, BPA, Northwest utilities, the Energy Trust of Oregon, Northwest Energy Efficiency Alliance, state energy agencies and public utility commissions, law firms with a significant presence in the energy sector, energy consulting companies, advocacy organizations and coalitions, and other energy companies and agencies have encouraged and supported employees that these organizations have identified as future leaders to participate in this course. # Why Take this Course?

The electricity sector is undergoing especially turbulent times as traditional business models are being altered due to renewable energy targets, climate change legislation, and energy efficiency and distributed generation requirements. Utilities are being required to deliver renewable electricity to their customers, but the challenge of transporting the renewable electricity from rural to urban areas is increasingly difficult due to citizen and environmental opposition to new power lines.
