### **Course Description**

Welcome to *Principles of Macroeconomics*! The study of Macro is certainly "alive" and pertinent in the world today. Economics is the study of how societies get the material things they want and need, given limited resources. *Macroeconomics* will introduce you to the study of the U.S. economy. Although the institutions, policies, and history of the U.S. economy will be touched upon, the emphasis of the course is on the theories which explain how the economy functions. The primary concern is on macroeconomics, which views the economy as a whole using aggregate concepts. Macroeconomics is the second course in the required series for economics majors and provides essential knowledge for business.

### Current Economic Events (CEE) Dropbox in D2L:

Describe a current event from a recent periodical and its connection to the course material for the week. Course material topics can be found listed at the beginning of each textbook chapter.
- b. One CEE will be dropped; therefore, there will be no makeups. If you must miss a CEE, that CEE will be the one to drop. If you miss more than one, it will negatively impact your grade.
- c. CEEs (10 points each week) will be worth 20% of the course grade.

### Discussion Forum (DF) in D2L

### Things You Can Do

By now you've probably heard the handwashing message 100 times, but proactive hygiene is still the most effective tool for staying healthy.
