WR 410/510 Book Publishing in Scotland

Course Description

This course offers a comprehensive view of the book publishing industry in the UK, particularly in Scotland. Various parts of the publishing process (editorial, marketing, design) and ecosystem (writers, publishers, distributors, retailers, etc.) in Scotland will be covered.

Course Objectives

This course aims to address the following topics:

- The history of book publishing, printing, and authorship in Scotland
- Literary festivals and award culture in Scotland
- Different style guide rules for copyediting in the UK
- Distribution and retail environments in the UK
- Scottish government involvement in the creative industries
- Scottish book publishing trade organizations
- Scottish writers and literary agents

Upon completion of the course, students should be able to

- Refine reflection and critical thinking skills
- Deliver an oral presentation
- Edit according to UK standards
- Present themselves professionally
- Intelligently discuss the Scottish book publishing industry

Topic Reflection Papers (50%)

There will be 5 workshops during this course in which you will be immersed in a particular area of the publishing ecosystem in Scotland and will have the chance to interact with organizations and people via guest lectures to learn from their expertise. For each workshop, you will write a brief reflection paper about the topic and what you learned from it.

Edinburgh Book Festival Write-Up (10%)

Edinburgh Book Festival is the largest international book festival in the world. Although Edinburgh Book Festival will not be held this year because of COVID-19, you'll be choosing one of the recorded events from past years to watch. Write a reflection pieces about what you learned from these three videos.

Length: 500 words (WR 510), 300 words (WR 410)

Scottish Book Publishing Paper (30%)

Write an essay on one of the following prompts:

- Drawing upon your understanding of Scottish book publishing historically and presently, what does the future look like for book publishing in Scotland?
- What are the social, political, and economic factors that shape Scotland's book publishing industry historically and contemporarily?
- Give an overview of the specifics of a particular book market (for example: comics, crime fiction, cookbooks, etc.) within Scotland
- Write an analysis for a Portland publisher wanting to enter the Scottish market. What is the Scottish book publishing environment like and how is it different from book publishing in Portland (or the US more generally)?

Length: 2000 words (WR 510), 1500 words (WR 410)

Participation (10%)

Participation is required in this course. This includes attendance to class (see the attendance policy for more information), but extends beyond that. In other words, attending class is not enough. You should read the assigned articles or book chapters before class and be prepared to discuss what you have read in class.
