Chorpenning led a review of the MEd program change and related courses before the guests arrived. The panel's primary concerns were the significantly increased number of credits (from 45 to 73 ) and the graduate distinction in the 400/500 courses.

McElhone and Sugimoto joined the meeting; McElhone provided an overview of the proposal.

- The reasons for the increase from 45 to 73 credits include:
- All students will complete an ESOL endorsement as part of the degree program. Given Oregon's demographics, there is increasing need for all elementary educators to be prepared to work with English language learners.
- Teachers Standards and Practices and the Oregon Department of Education have both added new requirements that needed to be incorporated into the curriculum.
- The program needed to be updated by adding content addressing students' social and emotional needs.
- The increased number of credits is in line with other elementary education programs in Oregon.
- For the graduate distinction in 400/500 courses, TSPC requirements for licensure must apply to undergraduate and graduate students. In order to create a meaningful graduate distinction, the program focused on activities that address research, advocacy, and leadership.
