- The new program proposal is driven by demand for online courses that began during the pandemic. The program uses primarily existing courses, is designed to be completed in one year (including summer term), and is targeted toward mid-career professionals. It would be the only online, applied Economics program available on the west coast.
- The moratorium on the existing Economics degree was driven by falling enrollment. It was designed as a PhD preparatory program, but demand for such programs has declined. While the moratorium is in effect, the department intends to conduct an assessment of the curriculum and the larger causes of the enrollment decline with an eye to possibly redesigning and relaunching the degree program.
