Dean Tankersley provided the Council members a preview of the recently completed Research and Graduate Studies Roadmap to 2030, focusing specifically on the initiatives and goals most directly related to graduate education. He also asked the members for topics they would like to see him address in future reports from the Dean to the Graduate Council.

Rissi raised a concern that the PhD in Public Affairs and Policy has a core course that is used by another program and asked if there was a place on the moratorium request form to note impacts on other units. Morris said there is not; she noted that any program can stop offering a course at any time – independent of a moratorium request – so these kinds of situations are difficult to monitor for.

Morris clarified that GC does not vote on moratorium proposals, but they are tasked with reviewing proposals and can provide comments to the Provost. Tankersley recommended that members provide feedback if they have it. Randol said that she will create and share a document where members can provide comments that will be shared with the Provost.
