Hackett brought up an unscheduled topic. She said students have expressed frustration at being required to pay separate application fees when they apply to graduate from two programs, for example a master's degree and a graduate certificate, but they only receive one diploma. Hanson said she was sure that at the graduate level students do receive a separate diploma for each credential earned, but she will follow up on this point with Degree Requirements and report back to the Council. Others also raised concerns about excessive student fees. Tankersley said he and Hanson could meet with the Provost and the Registrar and present them with Graduate Council recommendations about ways to possibly reduce student fees, for example, assessing only one application for graduation fee for two credentials.
