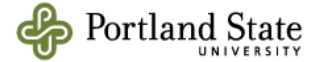

Additional Fees

- 1. Waitlist Application Fee:** A one-time, per-child fee of \$10 for student families, \$20 for faculty/staff families, and \$25 for community families is due before placement upon the waiting list.
 - 2. Registration Fee:** A one-time, per-child fee of \$100 for student families, \$150 for faculty/staff families, and \$165 for community families is due at the time of initial enrollment.
 - 3. Curriculum and Supplies Fee:** An annual fee of \$150 for transition and preschool classrooms and \$165 for infant/toddler classrooms is charged upon acceptance of enrollment.
 - 4. Late Payment Fee:** On the 15th of the month a \$15 late fee will be applied to your account if the tuition payment has not been received.
 - 5. Late Pick-Up Fee:** A \$10 fee will be charged to families who are ten minutes late. After 10 minutes, families will be charged \$1 per minute. If parents arrive late three or more times, the center reserves the right to charge families \$10 at 5:30 and a \$1 per minute thereafter.
 - 6. Fall Reservation Fee:** Parents who want to hold a space for their child in the fall academic-year program but skip the summer term are required to pay a non-refundable reservation fee: \$100 for student families, \$150 for faculty/staff families, and \$165 for community families.
- *One parent must be enrolled for 8+ undergraduate or 5+ graduate PSU credit hours per term (and continue for at least 2 additional terms) to qualify for student status enrollment each academic school year.
- *PSU student families may qualify for an additional child care tuition subsidy through the Jim Sells Child Care Assistance Program administered through the PSU Resource Center for Students with Children. Applications are available through the RCSC.
- *HG CDC is phasing out part-time preschool spaces. The current part-time preschool rates apply to current HG CDC Families grandfathered in to their part time spot.
- **PSU faculty/staff employed at .50 FTE and above are eligible for faculty/staff rates.
- **Families not currently affiliated with PSU (community families) are charged an additional 10% over the listed faculty/staff rates. Community enrollment is limited to a space-available basis after PSU families on the waitlist have been accommodated.
