


Average Monthly Medicaid Reimbursement and Private Pay Rates, 2017

TOP 5 MOST COMMON ADDITIONAL FEES

Oregon DHS contracted Portland State University's Institute on Aging to conduct a survey of a statewide sample of community based care settings. Results are based on provider responses to a self-administered questionnaire. A total of 350 adult foster homes and 308 assisted living, residential care, and memory care facilities responded.
