I've taught this class many times in the traditional style but this is the first time I'm teaching it this way. Since teaching the class all online is new and since Canvas is new, this will be an emergent process. We'll have to see how things are going and what works and what doesn't. This class will be a work in progress! I'll be patient with you as you negotiate this new system and I hope you'll be patient with me.

Since we aren't meeting in person, COVID protocols are less directly relevant, although I hope you maintain them for your protection and for the protection of others. Please prioritize your health and safety.

**REQUIRED TEXTBOOKS:** The Social Lens by Kenneth Allan. 3rd edition is preferred but older editions are acceptable.

**COURSE DESCRIPTION**: This course will provide students with an introduction to the Foundations of Sociological Theory, with a special emphasis on Classical Sociology. We will examine how sociological theories work as complex frameworks that sociologists use to explain and analyze social action, social processes, and social structures.

**COURSEWORK:** Each week's module will have a video lecture, a discussion assignment, and a written assignment. You should start the week by completing the reading before you watch the lecture. After you finish the reading and watch the lecture, make your first discussion post. Your first discussion post is due by 5pm on Tuesday. On Wednesday, check in to read other students' discussion posts. You need to reply to **TWO Different Posts** by 5pm on Friday. The week's assignment is due by 5pm on the next week's Monday - so Assignment 1 is due on Monday of Week 2, and so on.

Weekly Schedule:

- Monday 5pm Last week's assignment is due
- Tuesday 5pm First discussion post is due
- Friday 5pm Two different response posts are due

Grades:

- Weekly Assignments = 10 points each
- Discussion Posts = 4 points for first post, 2 points for each response post
- Final Exam = 100 points
- Total Points = 260

Final grades will be based on the standard curve (90% + = A, 80-89% = B, etc). You start the quarter with 0 points and accumulate them with each successful assignment.

**ATTENDANCE AND PARTICIPATION:** This course is heavily dependent on reading. You should read the assigned chapter at the beginning of each week's module. It is your responsibility to have internet access. Participation will take place in the Weekly Discussions. It is important to finish these on time so other students can respond to your posts and so you can get responses from other students. Late discussion posts don't help anybody.

**CLASS CONDUCT:** In an effort to make this class a learning environment for everyone, please be considerate of the other students in class. This is another reminder to participate in the Weekly Discussions on time! We will be discussing topics that may be controversial, so it is very important that we all maintain respect for the diversity of opinions represented in the class. This is an educational environment, so ideas may be questioned and critiqued but personal attacks will not be tolerated. Please treat online discussion posts with the same level of courtesy and respect for others that you would use in a traditional classroom.

# **Classroom Requirements for All Students and Faculty Due to Covid-19**

The University has established rules and policies to make the return to the classroom as safe as possible. It is required for everyone to follow all the Return to Campus rules and policies. To participate in this class, PSU requires students to comply with the following.

### Masks Required at all Times in Classroom

Wear a mask or face covering indoors at all times. Your mask or face covering must be properly worn (fully covering nose and mouth and tight fitting). Mesh masks, face shields, or face covering that incorporates a valve designed to facilitate easy exhalation are not acceptable. ## Vaccination

Health Check, Illness, Exposure or Positive Test for COVID-19

Complete the required self-check for COVID-19 symptoms before coming to campus each day.

If you are feeling sick or have been exposed to COVID-19, do not come to campus. Call SHAC to discuss your symptoms and situation (503.725.2800). They will advise you on testing, quarantine, and when you can return to campus.

If you test positive for COVID-19, report your result to SHAC and do not come to campus. SHAC will advise you on quarantine, notification of close contacts and when you can return to campus.

Please notify me, (i.e. your instructor), should you need to miss a class period for any of these reasons so that we can discuss strategies to support your learning during this time.

If I become ill or need to quarantine during the term, either I or the department chair will notify you via PSU email about my absence and how course instruction will continue.

## Failure to Comply with Any of these Rules

As the instructor of this course, the University has given me the authority to require your compliance with these policies. If you do not comply with these requirements, I may ask you to leave the classroom or I may need to cancel the class session entirely.
