

Dependency Override Appeal

Students under the age of 24 are generally considered dependent students for financial aid purposes and are required to provide parental data on the Free Application for Federal Student Aid (FAFSA). However, an exception may be made on an annual basis when circumstances exists that prevent the student from providing parental information on the FAFSA. This exception is known as a Dependency Override and allows a dependent student to be considered independent for financial aid purposes and therefore, exempt from providing parental data on the FAFSA.

You may qualify for a dependency override if you are estranged from your parents due to:

- Parental incarceration
- Parental abandonment
- An abusive family environment that threatens your health or safety
- Other unusual circumstances beyond your control

There are certain conditions which do NOT qualify as unusual circumstances. We are unable to approve a dependency override due to:

- Parent's refusal to contribute to your education
- Parent's unwillingness to provide information on the FAFSA or for verification purposes
- Parent(s) do not claim you as a dependent for income tax purposes
- You demonstrate self-sufficiency (i.e. live separate from your parents and support yourself)

If you believe your circumstances warrant a dependency override, please complete and submit the appeal form with the required documentation attached. An appeal must be submitted and reviewed annually even if a prior year's appeal was approved. Dependency override appeals are reviewed on a case-by-case basis. The submission of an appeal does not guarantee approval. All of the information submitted is strictly confidential and will not be disclosed to anyone without your written consent.

If your circumstances do not allow for a dependency override, you must provide parental information on your FAFSA. If you have already submitted your FAFSA, you will need to return to the FAFSA website and correct your application to include parental information including submission of the requisite signatures for student and parent.If your circumstances do not allow for a dependency override, you must provide parental information on your FAFSA. Required Documentation

- Personal Statement by Student On a separate page, tell us in your own words about your situation and describe your relationship with your parent(s), even if it is nonexistent. Please provide details regarding the events that led to your estrangement from them. Attach the dated and signed statement to this form.
- □ Supporting Statement from a Third-Party Professional The statement should speak to the individual's knowledge of your relationship your parent(s) as well as summarize your unusual circumstances. It must be signed, dated and should be on official letterhead. If letterhead is not obtainable, the person's name, title, phone number, business/organization name and address must be included. Examples of third party professionals include social workers, mental or medical health professionals, and members of clergy, school guidance counselors, coaches or teachers.
- Supporting Statement from an Objective Party- This dated and signed statement in support of your appeal should be from someone who has first-hand knowledge of your situation and the nature of your relationship with your parent(s). Examples of an objective party include an adult relative or neighbor, parent of a friend, employer or supervisor.
