

# **Articulation/Transfer Agreement**

PSU Contract # 369705

THIS ARTICULATION AGREEMENT ("Agreement") is entered into and by and between Portland State University ("PSU") and Portland Community College ("PCC").

#### Background

Whereas, PSU is a comprehensive research university that serves its students and the people of Oregon, the nation, and the world through the creation and transfer of knowledge in the liberal arts, the natural and social sciences, and the professions; and

Portland Community College (PCC).

Whereas, PCC and PSU are accredited by the Northwest Commission on Colleges and Universities (NWCCU) an institutional accrediting body recognized by US Department of Education.

It is in the interest of both PCC and PSU to facilitate the transfer of qualified students from PCC to PSU.

NOW THEREFORE, the Parties, for good and sufficient consideration, agree as follows:

PSU agrees to accept credits for students transferring from PCC to PSU, as outlined in Exhibit A, Articulation and Transfer Criteria, and Table A, Credit Transfer guide, which are hereby incorporated and made a part of this Agreement. In the event of a discrepancy between Exhibit A and this Agreement, the language of the Agreement shall take precedence.

#### Terms and Conditions

- A. Term; Termination. This Agreement shall commence on Fall 2015 or on the date of the last signature below, whichever is later, and shall terminate on Summer Term 2022 unless terminated earlier as provided herein. This Agreement shall be effective for students who apply to transfer from PCC to PSU beginning with PSU's Fall, 2015 term. This Agreement may be renewed for additional terms of any length by the mutual written agreement of the parties. Either party may terminate or suspend this Agreement for convenience upon sixty (60) days written notice; provided, however, that the parties shall discuss and reasonably attempt to resolve the issues that led to the notice of termination or suspension during the sixty (60) day period. Notwithstanding the termination of this Agreement, any students who have applied for transfer from PCC to PSU prior to or during the sixty (60) day period shall be treated as if this Agreement continues to be in effect. This Agreement may also be terminated as provided elsewhere in this Agreement.
- B. <u>Admission to PSU Is Not Guaranteed. Students shall apply for admission to PSU in accordance with the then-existing rules, policies, and procedures of PSU. This Agreement</u>

does not guarantee admission to PSU. Admission to PSU does not guarantee admission into any specific program or major at PSU. Admission to PSU under this Agreement and to any specific program or major is at the sole discretion of PSU.

- C. Oregon Residency Status. Students must meet the requirements of the residency rules of the Oregon State Board of Higher Education in order to be classified as Oregon residents for purposes of tuition and fees.
- D. General Provisions.

- 2. No Agency Relationship. In carrying out the responsibilities and obligations of this Agreement, neither party shall be acting as the agent or principal of the other with regard to dealings with third parties, including students. Neither party shall have the authority to make any statements, representations, or commitments of any kind or to take any action binding on the other except as provided for herein or authorized in writing by the party to be bound.
- 3. Termination Due to Non-Appropriation of Funds. If sufficient funds are not provided in future state legislature approved budgets for Portland State University (PSU), and these funds are not available from any applicable Federal, State of Oregon, or private sources to permit PSU, in the exercise of its reasonable administrative discretion, to continue this Agreement, and/or if any program for which this Agreement was established is abolished, cancelled, or otherwise terminated, this Agreement may be terminated without further liability to PSU by providing not less than thirty (30) days' of written notice to PSU Contract Officer, contract@pdx.edu. At a minimum, PSU agrees to provide compensation for materials and services up to the date of the written notice effectivity.
- 4. No Third Party Beneficiaries. PSU and PCC are the only parties to this Agreement and are the only parties entitled to enforce its terms. Nothing in this Agreement gives, is intended to give, or shall be construed to give or provide, any benefit or right, whether directly, indirectly, or otherwise, to third persons unless such third persons are individually identified

by name herein and expressly described as intended beneficiaries of the terms of this Agreement.

- <u>5. Force Majeure</u>. Any prevention, delay or stoppage due to strikes, lockouts, labor disputes, acts of God, inability to obtain labor or materials or reasonable substitutes therefore, governmental restrictions, governmental regulations, governmental controls, enemy or hostile governmental action, terrorism, civil commotion, fire or other casualty, and other causes beyond the reasonable control of the party obligated to perform, shall excuse the performance by such party for a period equal to any such prevention, delay or stoppage.
- <u>6. Execution and Counterparts</u>. This Agreement may be executed in several counterparts, each of which shall be an original, all of which shall constitute but one and the same instrument.
- 7. MERGER. THIS AGREEMENT CONSTITUTES THE ENTIRE AGREEMENT BETWEEN THE PARTIES. NO WAIVER, CONSENT, MODIFICATION, OR CHANGE OF TERMS OF THIS AGREEMENT SHALL BIND EITHER PARTY UNLESS IN WRITING AND SIGNED BY BOTH PARTIES. SUCH WAIVER, CONSENT, MODIFICATION, OR CHANGE, IF MADE, SHALL BE EFFECTIVE ONLY IN THE SPECIFIC INSTANCE AND FOR THE SPECIFIC PURPOSE GIVEN. THERE ARE NO UNDERSTANDINGS, AGREEMENTS, OR REPRESENTATIONS, ORAL OR WRITTEN, NOT SPECIFIED HEREIN REGARDING THIS AGREEMENT.

# AAS Program-to-Program Articulation and Transfer Criteria

Portland State University

and

Portland Community College
Associate of Applied Science in Fitness Technology

Portland State University (PSU) and Portland Community College (PCC) agree that students earning an Associate of Applied Science (AAS) degree in Fitness Technology from PCC may transfer to Portland State University with the following understandings:

- 1. This Agreement applies to students majoring in B.A./B.S. Applied Health and Fitness at PSU. (If the Agreement is program-to-program, and the student chooses a different major the courses from the AAS may or may not transfer to PSU.)
- 2. The intent of this Agreement is to facilitate baccalaureate attainment for students in the Fitness Technology AAS program at PCC. The combination of courses required in this AAS have been identified as providing the student with sufficient rigor and content to facilitate their success at PSU.
- 3. All courses numbered 100-level or above used to complete the AAS in Fitness Technology are eligible for transfer to PSU and may be applied as lower division credits toward the minimum 180 credits required to earn a baccalaureate degree. A minimum of 90 eligible credit hours of 100-level or above coursework is required in order to grant the student junior standing at PSU for the purposes of registration only. A grade of C or higher must be earned in courses that would ordinarily transfer as vocational/technical for those courses to be eligible for transfer to PSU. (See Table A Credit Transfer Guide).
- 4. The courses will transfer as identified in Table A Credit Transfer Guide.
- 5. As appropriate, courses transferred may fulfill lower division degree, general education, elective, and/or major requirements. See appropriate Advising Guide for requirements that are current as of Fall, 2015. (It is best for the student to work with an academic adviser to determine which catalog rules apply. Students must abide by the PSU seven year catalog eligibility rule, which holds that graduation requirements for a given catalog expire at the end of seven years.)
- 6. Students may have lower-division requirements to fulfill in addition to the AAS and will be responsible for completing all graduation requirements for PSU in effect at the time of graduation from PSU in order to earn a baccalaureate degree.

- 7. Students must meet PSU admission requirements in place at the time they apply for admission to PSU.
- 8. This Agreement will be in effect beginning Fall, 2015 (term/year), or upon date of last signature, whichever is later. Curriculum changes by either PSU or \_\_CC must be communicated in writing no later than June 30<sup>th</sup> of any academic year. This agreement will be reviewed every three (3) years to ensure the continued appropriateness and viability of this Agreement.

# College Preparatory Curriculum Transfer Articulation Degree Pathway Criteria

Portland State University

and

Portland Community College

Students following the transfer articulation degree map in Applied Science in Fitness Technology from Portland Community College (the "Program") may transfer to Portland State University in accordance with the following criteria and subject to the terms and conditions of this Agreement:

- 1. This Agreement applies to students majoring in B.A./B.S. Applied Health and Fitness PSU. (If the Agreement is program-to-program, and the student chooses a different major the courses may or may not transfer to PSU.)
- 2. The intent of the Agreement is to facilitate baccalaureate attainment for students at PCC. The combination of courses required in the Program have been identified as providing the student with sufficient rigor and content to facilitate their success at PSU.
- 3. All courses numbered 100-level or above used to complete the 2-year degree in the Program are eligible for transfer to PSU and may be applied as lower division credits toward the minimum 180 credits required to earn a baccalaureate degree. A minimum of 90 eligible credit hours of 100-level or above coursework is required in order to grant the student junior standing at PSU for the purposes of registration only.
- 4. The courses will transfer as identified in Table A Credit Transfer Guide.
- 5. As appropriate, courses transferred may fulfill lower division degree, general education, elective, and/or major requirements. See appropriate Advising Guide for requirements that are current as of Fall 2015. (It is best for the student to work with an academic adviser to determine which catalog rules apply. Students must abide by the PSU seven year catalog eligibility rule, which holds that graduation requirements for a given catalog expire at the end of seven years.)
- 6. Students may have lower-division requirements to fulfill in addition to the 2-year degree and will be responsible for completing all graduation requirements for PSU in effect at the time of graduation from PSU in order to earn a baccalaureate degree.
- 7. Students must meet PSU admission requirements in place at the time they apply for

admission to PSU.

8. Curriculum changes by either PSU or PCC must be communicated in writing no later than June 30<sup>th</sup> of any academic year.

#### **Advising Guide**

# Fitness Technology A.A.S. Articulation Agreement

Transferring to Portland State University (PSU) with the A.A.S. in Fitness Technology from Portland Community College (PCC) grants you junior status at PSU for the purposes of registration and for placement in PSU's University Studies General Education curriculum. It is important that you are also aware of other requirements needed in order to graduate from PSU. This is no substitute, however, for meeting with an academic advisor.

All credits used to toward graduation at PSU must be 100-level or above. The minimum number of credits needed to graduate from PSU is 180. Of those 180 credits, a minimum of 72 must be at the upper division (300 and 400) level. Note that PCC does not offer upper division coursework. Unless you are transferring upper division coursework from another 4-year college or university, you will need to complete at least 72 upper division credits at PSU.

To obtain a Bachelor's degree from PSU, there are three sets of requirements you need to complete:

- 1. Academic Major Requirements
- 2. Degree Requirements (BA, BS)
- 3. General Education Requirements (see below)
  Total: 180 credits with 72 upper division credits

The combination of credits from these three areas may not equal 180 credits or the 72 upper division credits, so you may have elective credits to take as well. While it is not a requirement to earn a minor, some students choose to use their elective credits toward a minor or even a second major. Talk with an academic adviser to determine your options.

# ACADEMIC MAJOR REQUIREMENTS

This articulation agreement applies only to the concentration in Physical Activity/Exercise within the Health Studies major. Refer to the PSU Bulletin or appropriate website for major requirements. If the AAS in Fitness Technology is completed, a minimum of 90 credits will transfer to PSU.

#### **DEGREE REQUIREMENTS**

Students pursuing a Health Studies: Physical Activity/Exercise degree must also complete the requirements for a B.A. or B.S. Credits from PCC may apply to either Bachelors degree (see transfer guide).

- 4 credits in Sciences/Math (excluding Math 100 or lower)
- 8 credits in Social Sciences/Sciences/Math (excluding Math 100 or lower)
- 4 credits: in Foreign Language level 203 or higher (for students with no prior language training, this will require completion of 101-103 and 201-203 in same language.)

<sup>1</sup>Students who are proficient in another language and who are waived the 4 credits of Foreign Language through a non-credit exam or TOEFL score must make up these 4 credits in the Arts & Letters distribution area (i.e., will need 16 credits in Arts & Letters, of which 4 must be in Fine & Performing Arts) in order to earn the 28 total credits required.

- 12 credits in Sciences (not including Math/Statistics; 8 of the 12 credits must be coursework with a lab or fieldwork)

- 4 credits in college-level Math/Statistics (excluding Math 100 or lower)

# GENERAL EDUCATION REQUIREMENTS

All colleges and universities have general education requirements designed to provide the breadth of knowledge and skills expected from college graduates. At Portland State University, you will be required to follow the University Studies program for general education. This program emphasizes an understanding of communication, critical thinking, social and ethical responsibility, and the diversity of human experience.

Generally, the University Studies program consists of four components: Freshman Inquiry, Sophomore Inquiry, Upper Division Cluster, and Senior Capstone. Because you will be transferring with the A.A.S. in Fitness Technology at PCC, you will enter PSU with junior status. That means you will only need to complete the Upper Division Cluster (3 classes = 12 credits) and Senior Capstone (1 six credit course) portions of the University Studies.

#### WHAT IF YOU DON'T COMPLETE THE A.A.S.?

If you do not complete the A.A.S. in Fitness Technology at PCC or complete the Health Studies: Physical Activity/Exercise major at PSU, you will be place in University Studies based on the number of transferable credits you complete. (Please note that if you do not complete the A.A.S., you may only transfer 12 credits of classes taken at the community level that transfer to PSU in the category of vocational/technical credits). Students begin with the course indicated below and complete the remainder of the UNST program. Once a student has registered for courses at Portland State University as a formally admitted student, additional credits completed at another institution will not change this placement. The exception to this policy is for students participation in co-admission.
