ByLaws updates—more revisions mandated by OAA:

- no voting rights for advisor, as per OAA & AAUP (although there is some lack of clarity about the latter)
- no acting chair for longer than 1 year

P&T updates:

- need to add section on eligibility and criteria for tenure and promotion of TT faculty
- University P&T document supersedes ours

Budget and Summer Session Update:

Data about the 2018-19 budget: shortfall for CLAS due to not making enrollment targets; revenue loss for PSU due to change in balance of students—fewer non-resident students and fewer grad students

Data about the 2019-20 budget: PERS

Impact of PERS increase will be in the ballpark of \$10M-\$15M for PSU in AY 19-20.

WLL budget: Our ratio during the academic year of costs per SCH is below the CLAS median. So we are in good shape there. But our summer budget is not sustainable: we are the most expensive producer of SCH in the summer in CLAS.

New summer courses updates, proposed by Greco and approved by Advisory:

- 1. Summer classes will no longer be taught by fulltime faculty (only taught by adjuncts and GTAs)
 - o A few exceptions are:
 - Russian classes because of their funding source
 - we will offer high enrollment class you can apply to teach, this should be a U class and online to attract enrollment
 - will continue to have Korean online in summer
- 2. Lower enrolled sections will be collapsed from two sections into one.
- 3. Online summer classes, if they run, will be taught by adjuncts.
 - o Note- WLL will not have financial support from OAI to run online courses in the future.
- 4. Summer search committees: fulltime faculty will be reimbursed to be on committee if search occurs when they are not on contract.

Some of the budget data presented:

RCAT: Winter 2018, 4th Week

- This version of the RCAT is used to make predictions for FY 18 performance and help set revenue targets for FY 19.
- CLAS had a revenue target of \$75,517,904 for FY18 (included a revenue decline of ~2%)
- CLAS projected \$73,764,315, a difference of \$1,753,589 (-2.3%)

CLAS Savings from 19 Open Positions on Pause FY 19

Savings: \$900,465

Amt. needed to balance FY 19 budget: \$360,000

Net: \$540,465

Four buckets: (1) Funding research clusters; (2) Saving for startup and lab renovation; (3) Supporting research in the humanities; (4) Student success/persistence initiatives
