 please scan documents and attaching them to the online form.
- If student is behaving in disruptive way, the student should be informed they are being disruptive, and you should:
 - o ask the student to please stop said behavior
 - o if they do not stop the disruptive behavior, you can then call CPSO from class and have the student removed

- Note: if you go to CPSO after your class to make a report, you will have to wait for said behavior to happen again in class and then call CPSO, they will not intervene if the conduct isn't happening at the moment
- If you are afraid to talk to student, go directly to the Student Conduct Office and make a report or file on their website

- If the concern does not require immediate attention, you can submit a CARE report form on their website. The CARE Team will follow up with you on the same or next business day. Please note that if you are submitting a CARE report outside of the business hours of Monday-Friday 8am-5pm or during a university observed holiday, it will be reviewed the following business day.
- CARE team not is not required to investigate, but they might
- Please make sure to keep a paper trail of all of your reports, issues, concerns, emails, etc.
- Contacting the CARE Team can redirect the issue from the instructor to more qualified staff who can help students
- If a student is extremely distressed in class and you think it might be due to a learning disability, etc., reach out to CARE team
