Suwako Watanabe Update on BA/BS Requirements:

- Suwako is chairing the Academic Requirement Committee (ARC).
- This committee exists because they want to find out what is causing the delay of finishing a degree in four years.
- They are currently reviewing requirements such as the 180 credit requirement to graduate, the residency requirement, etc.
- Of note for WLL, the committee is looking at the the [Second Language Admission Deficiency \(SLAD\)](#), imposed on incoming freshmen students who graduated from Oregon and high school.
- Members of the task force agreed that lowering the [second language BA/BS requirement](#) doesn't make sense.
